



#### Library Construction Bond Act (LCBA) Grants

Assisted the State Librarian with the first cycle of funding from the Library Construction Bond Act:



- supported the development of solicitation/application documents
- led the grant application intake process
- helped develop a technical assistance training session for 500+ public libraries
- managed a solicitation question-and-answer process
- managed the tax due diligence and grant agreement development and execution process for 38 approved grantees

**Adopted a new fee policy** to ensure long-term sustainability of the Authority's mission to support New Jersey higher education



Onboarded PFM Asset Management as the new manager of investments for the Authority's Other Post-Employment Benefits (OPEB) fund, resulting in significant investment earnings for the year.
